AMENDMENT NO. 2 TO RECREATION
GRANT CONTRACT NO. D-GGR15
BETWEEN THE STATE OF CALIFORNIA
DEPARTMENT OF WATER RESOURCES, AND
YUBA COUNTY WATER AGENCY

THIS CONTRACT AMENDMENT, entered into this 14 day
of August, 2003, by and between the State of California, acting by and
through the Department of Water Resources, hereinafter referred to as the
"State," and the Yuba County Water Agency, a public agency in the State of
California, duly organized, existing, and acting pursuant to the laws thereof with
its principal place of business in Marysville, California, hereinafter referred to as
the "Agency."

WITNESSETH, THAT;

WHEREAS, on May 10, 1966, the State and the Agency entered into
recreation grant Contract No. D-GGR15 under the Davis-Grunsky Act, which
provided for grants from the State to the Agency to assist in financing the
Agency's recreation plan at New Bullards Bar Dam and Reservoir, the initial
water supply and sanitary facilities, and fish and wildlife enhancement connected
therewith and set forth in the terms and conditions of such grants; and

WHEREAS, on August 14, 1973, the State and the Agency entered into
Contract Amendment No. D-GGR15-A1 amends Contract No. D-GGR15; and

WHEREAS, Contract No. D-GGR15 and D-GGR15-A1, hereinafter
referred to as "the Contract," required the Agency to install certain specifically
described recreation facilities; and

WHEREAS, the Agency has installed the required recreation facilities, substantially as set forth in Part C Recreation Plan of the original contract and amendment A1.

WHEREAS, the State and the Agency desire to amend said contract.

NOW THEREFORE, it is mutually agreed and amended as follows:

Part C Recreation Plan

Delete Part C Recreation Plan Article 15 (c) of the original contract and amendment A1 Article 15 (c) and replace with the revised Part C Recreation Plan Article 15 (c) attached hereto and incorporated herein. Part C describes the constructed recreation facilities that exist and meet the requirements of the "Contract."

Article 17. Operation for Recreation Purposes, (d) Fees for Recreational Use

Delete Article 17 section (d) as amended and substitute the following:



(d) Fees charged for recreation use of the project shall be consistent with fees being currently charged in the general area of the project for similar recreation use and shall reflect reasonable operation and maintenance expenses of Grantee, including any costs incurred by Grantee, for additional services provided in connection with the recreation facilities. The fees charged by the Grantee for the use of the project recreation facilities (including, but not limited to, fees for inspection, licenses and permits for boats) shall not differentiate in a discriminatory manner and shall be reasonably equal between different recreation groups, so as to allow statewide use of the project recreation facilities by the general public. Monthly or annual fees at a reduced rate without discrimination and discounts recognized and applied at other comparable recreation facilities in the area, such as a senior citizen discounts, are acceptable if applied equally to all users.


In all other respect, the Contract shall remain in full force and effect as executed.



Part C Recreation Plan

Article 15 (c) is amended to read

15. DESCRIPTION AND LOCATION OF ONSHORE RECREATION FACILITIES

The Agency has constructed the following onshore recreation facilities to be operated, and maintained substantially at the locations and in the manner specified in this Part C and contained in the Revised Exhibit R dated February 26, 1993 filed with the Federal Energy Regulatory Commission Project No. 2246

(c) Other Onshore Recreation Facilities

- (1) Sunset Vista observation point
 - (a) 1 restroom building pit pump-out with 4 toilet seats
 - (b) parking for 65 autos
- (2) Schoolhouse camp area
 - (a) 4 restroom buildings with 3 flush toilets, 1 flush urinal, 2 sinks (women's 2 toilets, 1 sink; men's 1 urinal, 1 toilet, 1 sink), handicap accessible
 - (b) 1 restroom building pit pump-out with 2 toilet seats
 - (c) 67 family camp units tent, trailer, (20 single sites changed to multi-family units) with 1 stove, 1 table/bench combo, parking spur (double units have 2 stoves and 2 table/bench combos)
- (3) Burnt Bridge camp area facilities removed and site being restored as per amended recreation plan
- (4) Hornswoggle group camp area
 - (a) 2 restroom buildings with 3 flush toilets, 1 flush urinal, 4 sinks
 - (b) 2 restroom buildings pit pump-out with 2 toilet seats
 - (c) 5 group camp units each with 4 stoves, 4 table/bench combo, 1 work table, tent sites, parking for 12 autos
 - (d) group sites are identified as #1 Sugar Pine for 25 people, near 1 pit toilet; #2 Douglas Fir for 50 people, near 1 pit toilet; #3 Madrone for 25 people, near 1 flush toilet; #4 Ponderosa for 25 people, near 1 flush toilet; #5 Manzanita for 25 people, near 1 flush toilet; and #6 RV group camp for 5 RVs and 25 people, no toilet facilities

- (5) Dark Day picnic area and campground
 - (a) 2 restroom buildings pit pump-out with 2 toilet seats
 - (b) 2 restroom buildings pit pump-out with 4 toilet seats
 - (c) 1 floating comfort station with 4 foot-pedal operated monomatic toilets and appropriate pump-out containers, and fish cleaning facility
 - (d) 14 family picnic units with 1 stove, 1 table/bench combo, parking for 30 autos
 - (e) 16 family camp units with 1 stove, 1 table/bench combo, tent site, parking spur
 - (f) 1-2 lane boat ramp, parking for 94 auto/trailers
- (6) Cottage Creek picnic area permanently closed and area is being restored as per amended recreation plan (this area is used for overflow camping on busy weekends, no water, no toilet facilities)
- (7) Cottage Creek boat launching area
 - (a) 1 restroom building pit pump-out with 4 toilet seats
 - (b) 1-2 lane boat ramp, with parking for 60 auto/trailers
 - (c) 2 picnic tables
- (8) Garden Point boat access camp area
 - (a) 1 floating comfort stations with 4 foot-pedal operated monomatic toilets and appropriate pump-out containers, and fish cleaning facilities
 - (b) 20 boat access camp units with 1 stove, 1 table/bench combo, clearing for tent
 - (c) 4 pit pump-out toilets with 1 seat each
- (9) Frenchy Point boat access camp area is closed due to deterioration and erosion of the area, facilities removed
- (10) Madrone boat access camp area
 - (a) 1 floating comfort station with 4 foot-pedal operated monomatic toilets and appropriate pump-out containers, and fish cleaning facility
 - (b) 10 boat access camp units each with 1 stove, 1 table/bench combination, clearing for tent
 - (c) 2 pit pump-out toilets with 1 seat each
- (11) Sufficient garbage facilities at appropriate locations
- (12) Such entrance stations as are necessary for the control or use of the recreation area, or for the dissemination of information
- (13) Sufficient recreation access roads and circulation roads at appropriate locations to serve the onshore recreation facilities

- (14) Installation of other facilities: the installation within the recreation area of any facility which affects the recreational or fish enhancement uses of the Project and which is not described in the Contract shall be subject to the prior written approval of the State. This subdivision shall not apply to the Dam or to any modifications thereof or additions thereto, nor shall it be construed as a waiver or any other provision of the Contract.
- (15) This recreation plan may be modified by mutual agreement between the Davis-Grunsky Program Manger or his designee of the Department of Water Resources and the General Manger or his designee of Yuba County Water Agency. The modifications to the recreation plan could reflect changes in facilities required by minor changes in usage or legal requirements.
