Order Approving As-Built Exhibit K and Amending License

(Issued July 8, 1980)

William W. Lindsay, Director, Office of Electric Power Regulation.

Yuba County Water Agency, Licensee for the constructed Yuba River Project No. 2246, filed on July 6, 1971, and revised February 13, 1978, as-built Exhibit K maps for Commission approval pursuant to Article 5 of the license. ¹

The Yuba River Project occupies approximately 3,834.47 acres of United States lands. An annual charge, effective as of the effective date of the license, for the use of these lands is required by amending Article 57 of the license.

The Exhibit K essentially conforms to the Commission's Rules and Regulations (1979) and is approved by this order. Approval of the Exhibit K is an administrative action and would not be a major Federal action significantly affecting the quality of the human environment.

It is ordered that:

(B) The superseded Exhibit K maps noted in paragraph (A) are eliminated from the license.

(C) Subparagraph (ii) of Article 57 of the license is amended to read as follows:

(ii) For the purpose of recompensing the United States for the use, occupancy, and enjoyment of 3834.47 acres of its lands, exclusive of transmission line rights-of-way, an amount as may be determined from time to time pursuant to the Commission's Regulations;

(D) This order is final unless a petition appealing it to the Commission is filed within 30 days from the date of its issuance, as provided in Section 1.7(d) of the Commission's Regulations, 18 CFR 1.7 (d) (1979), as amended, 44 Fed. Reg. 46449 (1979).
