Order Approving As-Built Exhibit R Drawings

(Issued April 25, 2006)

William Guey-Lee, Chief, Engineering and Jurisdiction Branch, Division of Hydropower Administration and Compliance.

On February 13, 2006, Yuba County Water Agency (Licensee) filed as-built drawings of recreation improvements pursuant to Ordering Paragraph (E) of the Order Approving Recreation Plan

With Modification, Requiring Study Plan, And Amending License for the Yuba River Project No. 2246, ¹ and Ordering Paragraph (D) of the Order Approving Revision of the Recreation Plan. ² The project is located on the North Yuba River, in Yuba, Sierra, and Nevada Counties, California.

Ordering Paragraph (D) of the August 1993 order requires the licensee to construct, maintain, and operate reasonable recreational facilities, including wharves, launching ramps, beaches, picnic and camping areas, sanitary facilities, and utilities, giving consideration to the needs of the physically handicapped. Ordering Paragraph (E) requires the licensee to file as-built drawings of the completed renovations to the recreation areas, an assessment of the adequacy of project recreation opportunities, and the licensee's plan to provide for future recreation access.

Ordering Paragraph (A) of the April 5, 2004 order modifies the recreation plan to include seasonal closure of Moran Road to vehicular traffic from October 15 to May 1 each year, road surface and drainage improvements, a parking area for approximately 7 cars, and an accessible portable toilet. Ordering Paragraph (D) requires the licensee to file as-built drawings of the completed Moran Road recreation improvements.

The licensee filed revised Exhibit R drawings depicting improvements to recreation facilities at the project. The revised drawings show improvements to Moran Road, the Cottage Creek parking lot and boat ramp, and parking lot and access road improvements at the Dark Day Boat Launch area. The filed drawings conform to the Commission's regulations at 18 C.F.R. §4.41(vii), and are approved by this order.

The Director orders:

(A) The following revised Exhibit R Drawings, filed on February 13, 2006, are approved and made part of the license:

(B) Within 45 days of the date of issuance of this order, the Licensee shall file the approved exhibit drawings in aperture card and electronic file formats.

a) Four sets of the approved exhibit drawings shall be reproduced on silver or gelatin 35mm microfilm. All microfilm shall be mounted on type D (3-1/4 " × 7-3/8 ") aperture cards. Prior to microfilming, the FERC Drawing Number (*i.e.*, P-2246-156 through P-2246-163) shall be shown in the margin below the title block of the approved drawing. After mounting, the FERC Drawing Number shall be typed on the upper right corner of each aperture card. Additionally, the Project Number, FERC Exhibit (*e.g.*, R-9, R-10, R-11, *etc.*), Drawing Title, and date of this order shall be typed on the upper left corner of each aperture card. See Figure 1.

Two of the sets of aperture cards shall be filed with the Secretary of the Commission, ATTN: OEP/DHAC. The third set shall be filed with the Commission's Division of Dam Safety and Inspections San Francisco Regional Office. b) The Licensee shall file two separate sets of exhibit drawings in electronic raster format with the Secretary of the Commission, ATTN: OEP/DHAC. A third set shall be filed with the Commission's Division of Dam Safety and Inspections San Francisco Regional Office. Exhibit G drawings must be identified as (NIP) material under 18 C.F.R. §388.112. Each drawing must be a separate electronic file, and the file name shall include: FERC Project-Drawing Number, FERC Exhibit, Drawing Title, date of this order, and file extension in the following format [P-2246-156 Exhibit R-9, Yuba River Project, Recreation Facilities, MM-DD-2006.TIF]. Electronic drawings shall meet the following format specification:

IMAGERY --black & white raster file

FILE TYPE --Tagged Image File Format, (TIFF) CCITT Group 4

RESOLUTION --300 dpi desired, (200 dpi min)

DRAWING SIZE FORMAT --24" × 36" (min), 28" × 40" (max)
