Pursuant to 18 CFR § 5.16(a) and (c), the Yuba County Water Agency (YCWA), as owner and operator of the Yuba River Development Project (Project), FERC Number 2246, files with the Federal Energy Regulatory Commission (FERC) the attached Draft Application for New License Major Project – Existing Dam (Draft License Application, or DLA).

YCWA is filing with FERC all portions of the DLA, with the exception of Appendix E6 to Exhibit E, following the Commission's eFiling guidelines.

The DLA was prepared in accordance with FERC's Integrated Licensing Process, and includes six volumes. A copy of the transmittal letter is included with each volume.

Appendix E6 contains material such as the Yuba River Water Balance/Operations Model, technical memoranda for relicensing studies, and a helicopter video of Project facilities and stream reaches. This material has been provided to Relicensing Participants and is available on YCWA's Relicensing Website (www.ycwa-relicensing.com). Since the size and format of the material precludes its uploading to FERC's e-Library system, FERC agreed that this material would not be filed with the DLA, but would be available to Relicensing Participants on YCWA's Website. YCWA will file the material with FERC in its final Application for New License Major Project – Existing Dam (FLA) in April 2014.
