Initial Statement

Before The Federal Energy Regulatory Commission

Application for a New License for a Major Project – Existing Dam

1.0 Introduction

The Yuba County Water Agency (YCWA, Licensee or Applicant) has prepared this Initial Statement, as part of its Application for a New Major License from the Federal Energy Regulatory Commission (FERC or Commission) for the Yuba River Development Project (Project), FERC Project Number 2246. The Project is located in part on United States lands managed by the United States Department of Agriculture, Forest Service, as parts of the Tahoe and Plumas national forests, and on lands administered by the United States Army Corps of Engineers (USACE) as parts of Englebright Reservoir and Dam.

This Initial Statement is prepared in conformance with Title 18 of the Code of Federal Regulations (CFR), Subchapter B (Regulations under the Federal Power Act), Part 5 (Integrated Licensing Process [ILP]). In particular, this Initial Statement conforms to the regulations in 18 CFR Section (§) 4.51(a), which pertain to the contents of an Initial Statement, and in 18 CFR § 5.18(a), which requires, in part, that the Application for a New License include certain general information. This application is being filed under the ILP, as defined by 18 CFR § 5.18.

2.0 Applicant and Requested Term of New License

YCWA formally applies to the Commission for a new license for the Project, a water power project, as described in the attached exhibits. The initial license for the Project was issued by the Federal Power Commission, FERC's predecessor, to YCWA on May 16, 1963, effective on May 1, 1963. The Federal Power Commission's May 6, 1966, Order Amending License changed the license's effective date to May 1, 1966, for a term ending on April 30, 2016.

On November 5, 2010, YCWA filed with FERC a Notice of Intent to File an Application for a New License for the Project on or before April 30, 2014.

YCWA proposes to continue operating the Project for the next 50 years with one modification to an existing generation facility (i.e., the addition of a tailwater depression system to New Colgate Powerhouse), the addition of a new flood control outlet to New Bullards Bar Reservoir, and the adoption of the resource management measures proposed in its license application.

A new 50-year license is requested for the Project because YCWA anticipates incurring substantial expenses for modifications to its generation facility, the addition of the flood control

outlet, and implementing protection, mitigation, and enhancement measures, including constructing and refurbishing recreation facilities and access roads thereto during the next license term.

6.0 Applicant's Organizational Status

Established in 1959 by the Yuba County Water Agency Act (West's California Water Code App., §§ 84-1 – 84-28) and headquartered in Marysville, California, YCWA is a public agency

governed by a seven-member Board of Directors consisting of the five members of the Yuba County Board of Supervisors and two members elected from districts that together encompass Yuba County. YCWA was created “for the purpose of accomplishing a function of statewide importance.” (YCWA Act, § 1, West’s California Water Code App., § 84-1). YCWA has the power to: 1) “control the flood and storm waters of the agency and the flood and storm waters of streams that have their sources outside of the agency, which streams and flood waters flow into the agency, and to conserve such waters for the beneficial and useful purposes of said agency;” 2) “do any and every lawful act necessary in order that sufficient water may be available for any present and future beneficial use;” and 3) “develop hydroelectric power to the extent that such power can be developed in connection with the construction and operation of its projects.” (YCWA Act, §§ 4, 4.1 & 4.2; West’s California Water Code App., §§ 84-4, 84-4.1 & 84-4.2.)

7.0 Pertinent Statutory and Regulatory Requirements of the State of California

The statutory or regulatory requirements of California, the State in which the Project is located, that may affect the Project with respect to: 1) bed and banks; 2) appropriation, diversion, and use of water for power purposes; 3) right to engage in the business of developing, transmitting, and distributing power; and 4) any other business necessary to accomplish the purposes of the license under the Federal Power Act, are:

- California Fish and Wildlife Code §§ 1600-1616 – Require that parties notify the California Department of Fish and Wildlife (Cal Fish and Wildlife) and follow the prescribed requirements before substantially changing or using any material from any streambed.
- California Water Code §§ 1200-1831 – Specify requirements and procedures for appropriation and use of water for power purposes.
- California Water Code § 13160; Title 23, California Code of Regulations §§ 3855-3861 – California Water Code section 13160 designates California State Water Resources Control Board (SWRCB) as the state water pollution control agency for Federal Water Pollution Control Act and any other federal act. Title 23, California Code of Regulations, sections 3855-3861 specify requirements and procedures for applications for water quality certificates required under federal law.
- California Water Code §§ 6075-6157 – Specify powers of the California Division of Safety of Dams (CDSOD) and specify requirements and procedures for the inspection and maintenance of dams.

The steps which YCWA has taken or plans to take to comply with each of the laws cited above are described below.

- YCWA will submit a notification to Cal Fish and Wildlife under California Fish and Wildlife Code section 1602 if any new construction work in any streambed is required for the Project.

- YCWA already has the water rights necessary to operate the Project.
- YCWA will file an application for a Water Quality Certificate with the State Water Resources Control Board (SWRCB) within 60 days after the date that FERC issues a notice that YCWA's Application for New License is Ready for Environmental Analysis [18 CFR § 5.23(b)(1)].
- YCWA cooperates, and will continue to cooperate, with CDSOD on annual inspections of Project dams.

8.0 Proprietary Rights Necessary to Construct, Operate and Maintain the Project

YCWA owns all existing Project facilities and has the necessary proprietary rights, title and interest in lands and water to operate and maintain the Project. No Project facilities (other than recreational facilities) are federally owned or operated. YCWA has the necessary proprietary rights, title and interest in lands and water to construct the proposed new flood control outlet at New Bullards Bar Reservoir, new tailwater depression system at New Colgate Powerhouse, and new recreation facilities.

The Project is not located within any designated cities, towns or subdivisions, nor is a Project dam located within 15 miles of any city or town with a population of 5,000 or more.

The Project passes water through the federally-owned Englebright Reservoir, which is located on the Yuba River near the City of Marysville. However, none of the Yuba River Development Project facilities are integral parts of Englebright Dam; the Project's Narrows 2 Power Conduit and Narrows 2 Powerhouse, the most downstream Project facilities, are not connected or attached to Englebright Dam in any way, nor do they intersect the dam in any way (e.g., the powerhouse power tunnel and penstock do not pass through the dam).

Englebright Dam, which is about 260 ft high and forms Englebright Reservoir, was constructed by the California Debris Commission in 1941. The dam and the surrounding land are owned by the United States. When the California Debris Commission was decommissioned in 1986, administration of Englebright Dam and Reservoir passed to the USACE. The primary purpose of the dam is to trap and contain sediment derived from extensive historic hydraulic mining operations in the Yuba River watershed. Englebright Reservoir is about 9 miles long with a surface area of 815 acres. Englebright Reservoir when first constructed had a gross water storage capacity of 70,000 acre-feet (ac-ft); however, due to sediment capture, the gross water storage capacity today is approximately 50,000 ac-ft.

The Project does not use any other federal facilities or any State of California facilities. No irrigation districts own or operate facilities within the Project.

Yuba County Water Agency (YCWA) owns and operates the Federal Energy Regulatory Commission (FERC)-licensed Yuba River Development Project, a water power project in Yuba, Sierra and Nevada counties, California, on the Yuba River; Middle Yuba River; North Yuba River; and Oregon Creek, a tributary to the Middle Yuba River. The Project is composed of three developments – New Bullards Bar Minimum Flow, New Colgate and Narrows 2. The current FERC license for the Project expires on April 30, 2016.

On or about April 30, 2014, YCWA applied to FERC for a New License for a Major Project – Existing Dam. The Application describes the Project facilities, Project operation, estimated costs related to continued operations, and general information. The Application also includes a description of environmental and recreational resources in the vicinity of the Project; an assessment of potential adverse environmental impacts associated with continued Project operation and maintenance; and YCWA's proposed resource management measures to protect and enhance environmental and recreation resources, and mitigate any Project impacts.

As required by 18 CFR § 5.2(b), at this time YCWA announces the availability for inspection and reproduction of the Application. The Application has been made available in electronic format to pertinent resource agencies and Native American Tribes, and a paper copy is available for inspection and reproduction during regular business hours at the Public Library in Marysville and at YCWA's office at 1220 F Street, Marysville, CA (tel: 530-741-6541). The Application is also available on YCWA's Relicensing Website at www.ycwa-relicensing.com. A copy of the Application may also be obtained upon request from YCWA after reasonable reimbursement to YCWA for postage and reproduction.

Upon acceptance of the Application for filing, FERC will publish notices soliciting additional public participation.
