Recent developments have resulted in a need to modify the Historic Properties Management Plan (HPMP). The needed modifications to the HPMP will be made following additional consultation efforts by YCWA with tribes, agencies, and SHPO. Once the modified HPMP has gone through another round of review by these consulting parties, the modified HPMP will be filed with FERC. YCWA anticipates that the final modified HPMP will be filed with FERC by the end of 2017.

The remaining eight of the 21 implementation plans are included in Attachment 1 to this Appendix E3. Each of the eight plans is discussed below.

- YCWA Proposed Condition GS2, Log Cabin and Our House Diversion Dams Sediment Management Plan. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 1D, LCOH). Subsequently, YCWA made a minor modification to the plan. YCWA reviewed the modification to the plan with the Forest Service and understands the Forest Service agrees with the modification. The modified plan is included in this Appendix E3.
- YCWA's Proposed Condition WR1, *Hazardous Materials Management Plan*. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 1B). Subsequently, YCWA made a minor modification to the plan at the Forest Service's request. YCWA reviewed the modification to the plan with the Forest Service and understands the Forest Service agrees with the modification. The modified plan is included in this Appendix E3.
- YCWA's Proposed Condition, *Streamflow and Reservoir Level Compliance Monitoring*<u>Plan</u>. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 1F). Subsequently, YCWA made a minor modification to the plan. YCWA reviewed the modification to the plan with the Forest Service and understands the Forest Service agrees with the modification. The modified plan is included in this Appendix E3.
- YCWA's Proposed Condition WR9, *Drought Management Plan*. This implementation plan was not previously filed with FERC, and YCWA understands from the Forest Service that it is not a plan for which the Forest Service would file a FPA Section 4(e) condition. The plan is included in this Appendix E3.
- YCWA's Proposed Condition AR7, *Upper Yuba River Aquatic Monitoring Plan*. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 1H, UYR). Subsequently, YCWA made a minor modification to the plan at the Forest Service's request. YCWA reviewed the modification to the plan with the Forest Service and understands the Forest Service agrees with the modification. The modified plan is included in this Appendix E3.

- YCWA's Proposed Condition RR1, *Recreation Facilities Plan*. This implementation plan was not previously filed with FERC. YCWA and the Forest Service have completed development of the plan, and YCWA understands the Forest Service agrees with the plan, which is included in this Appendix E3.
- YCWA's Proposed Condition LU1, *Transportation System Management Plan*. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 1N). Subsequently, YCWA made a few minor modifications to the plan. YCWA reviewed the modifications to the plan with the Forest Service and understands the Forest Service agrees with the modifications. The modified plan is included in this Appendix E3.
- YCWA's Proposed Condition LU2, Fire Prevention and Response Plan. YCWA and the Forest Service reached agreement on this implementation plan and YCWA filed it with FERC on October 27, 2016 (Accession No. 20161027-5175 Encl. 10). Subsequently, YCWA made a minor modification to the plan at the Forest Service's request. YCWA reviewed the modification to the plan with the Forest Service and understands the Forest Service agrees with the modification. The modified plan is included in this Appendix E3.
